Aamjiwnaang Law Day Court House Tour

On Tuesday, April 14th, eleven high school students from Alexander, St. Clair and Scits were bused to the Sarnia Court House for the annual Aamjiwnaang Law Day Court House Tour. Joining them were two Aamjiwnaang Band Councillors, our Secondary School Native Education Worker, two Aamjiwnaang Education Committee members, and a community member of Aamjiwnaang. Students enjoyed rotating around the courtroom sitting where the judge, Crown attorney, defence council, defendants, and witnesses would sit during a trial in the Ontario Court of Justice. Justice of the Peace Helen Gale supplied a gown for the students to wear while sitting on the bench. They also had the opportunity to meet with the Honourable Justice Desotti of the Superior

Court of Justice, Her Honour Justice D. Austin, Her Worship Gale and His Worship M. Rogers of the Ontario Court of Justice, who explained their roles in the court and the path that had led them to their professions. First Nations justice professionals were invited to speak to the students about their parts they played within the justice system. Law Day at the Scarborough Courthouse

Grade 11 students enrolled in the workplace streamed program got an extraordinary opportunity to learn about some of the careers available in the justice system when they visited the Scarborough Courthouse for a special Law Day Career Day event on April 16th. The event took its direction from the mock trial, *R. v Lee*, about a youth charged with shoplifting. The session opened with Crown attorney and defense council demonstrating an examination and cross-examination of a witness. Following the demonstration, a variety of court staff and justice professionals introduced themselves to the students and explained how they would come into contact with the accused person in the scenario, or be involved in the proceedings, if the trial had taken place in the Scarborough Courthouse.

Students also observed court in session and toured a special court room used for video conferencing for child witness testimony. The day wrapped up with a quiz and prizes for the students.



Hamilton OJEN Committee Holds a Law Day Twitter Moot

For Law Day 2015, the students of Hamilton Wentworth District School Board and Hamilton Wentworth Catholic District School Board participated in the inaugural Twitter Moot of the Hamilton Justice Education Network. OBA-OJEN Law Day Secondary School Mock Trial Partnership

The first year of the OJEN-OBA Law Day Secondary School Mock Trial program has wrapped up and the verdict is – it was a tremendous success!

Eighty seven schools from every region of the province participated, a 42% increase over last year. In Ontario East, participation expanded to 10 schools from 2 last year. 750 students took part in the LDSSMT tournaments and an additional 112 participated in affiliated tournaments for a total of 842 students.

The response from teachers has been generally positive. They appreciated the fact that more students had the opportunity to perform their mock trials in a court house setting and that more students could be acknowledged for their accomplishments. Whereas in previous years, when the primary focus of the preliminary rounds was to select the teams to advance to the finals, the new system recognized second and third placed teams and gave awards to individual students for top advocate and best witness.

Teachers also preferred the points-based scoring system used this year and the detailed feedback given by the judges.

Although in many cases, teams that had previously participated in OBA tournaments won the regional competitions, several new teams came in second or third or placed highly. Having each team guaranteed a lawyer coach this year played a big part in levelig the playing field and allowing all students to achieve their potential.
